Animal and Plant Quarantine for Foreign Workers

1. What is animal and plant quarantine?

- ☞ In order to prevent the introduction and spread of overseas plant and animal pests and infectious diseases into Korea, quarantine is conducted on agricultural products, animals, and livestock brought into the country by overseas travelers.









Agricultural products such as fresh fruits and vegetables and animals and livestock brought into the country are inspected for the presence of pests and prohibited products, and measures are taken to pass or fail (disinfection, disposal, and return)

- ※ Related Laws: Plant Quarantine Act (Act No. 13383), Livestock Epidemic Prevention Act (Act No. 14641)

2. Items subject to plant and animal quarantine

- ☞ Plants: Plants including **fruits** such as mango, apple, and orange, seedlings, seeds, and all agricultural products such as rice, potatoes, sweet potatoes, sesame seeds, ginseng, dried peppers, walnuts, and soil.
- ☞ Animals: All animal and livestock products, including **meat products** such as ham, sausage, and jerky; dairy products such as milk, cheese, and butter; meats such as beef and pork; and eggs.
- ☞ Import prohibited items (example)

3. Notification of quarantine of animals and plants

- ☞ All animals and plants you carry **must be quarantined without exception.**
- ☞ Anyone bringing in animals and plants from a foreign country must either 1) check the box on the Customs "Traveler's Carry-On Declaration Form" to indicate that they are carrying quarantined items, or 2) verbally report to **the Animal and Plant Quarantine Officer at the Korea Animal and Plant Health Inspection and Quarantine Headquarters stationed at the airport.**



4. Animal and Plant Quarantine Procedures

1. (Entry) Travelers will enter the Airport Only Arrival Hall using the traveler's passage, and the deposited cargo will go to the baggage carousel (conveyor belt) after passing the X-ray inspection machine.
2. (X-ray fluoroscopy) Customs officers will apply **an electronic tag (green or orange) to bags** suspected of containing animal or plant quarantine items after a fluoroscopic examination in the X-ray inspection room.
3. (Quarantine canine inspection) Quarantine canines are used to inspect travelers' carry-on items and apply the quarantine tag when they detect an animal or plant subject to quarantine.
4. **Voluntary declarant of bags or quarantined items with animal and plant quarantine tags** will be directed to the animal and plant quarantine inspection station.

- ※ If you do not check the presence of quarantine items on the traveler's hand luggage declaration form or verbally declare the presence of animals and plants to the quarantine officer before the joint inspection team and customs inspection team, **you will be fined on the spot for 'carrying quarantine items - not declared'**.
- 5. Items that fall under the prohibited quarantine items will be destroyed and returned, and items that are not prohibited will be passed if no pests are found during on-site inspection.
- 6. If seeds, seedlings, and other edible plants or pests are detected, a laboratory inspection will be conducted, and depending on the type of pest, they will be disinfected or destroyed (returnable).

5. Imposing fines on violators of animal and plant

- ☞ **A minimum fine of 100,000 won and a maximum fine of 500,000 won will be imposed** for violations such as failing to declare and undergo quarantine even though the traveler is in possession of animals and plants or making a false declaration.

6. Quarantine inquiry upon departure with animals and plants

- ☞ Just as overseas travelers must comply with Korea's animal and plant quarantine regulations when entering the country, if you are leaving the country with animals and plants, you must check whether they are allowed to be imported according to your country's quarantine regulations. Before leaving the country, please check whether the items can be exported through the Nuri website of the Ministry of Agriculture, Food and Rural Affairs Quarantine Headquarters or contact the airport office before departing.
